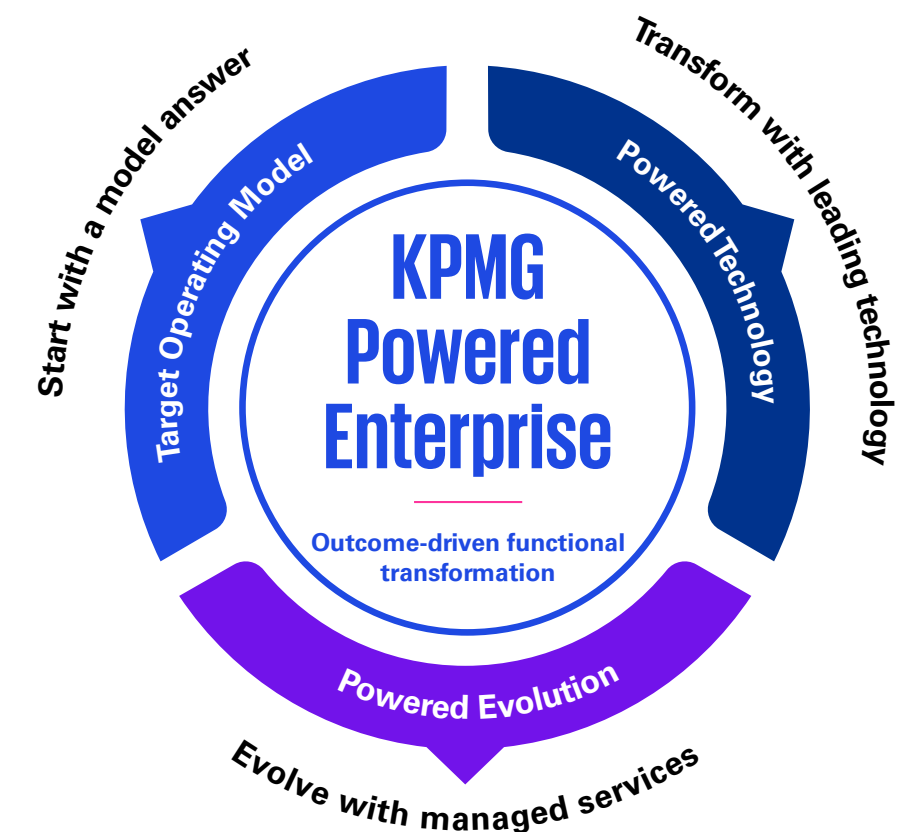

Governance

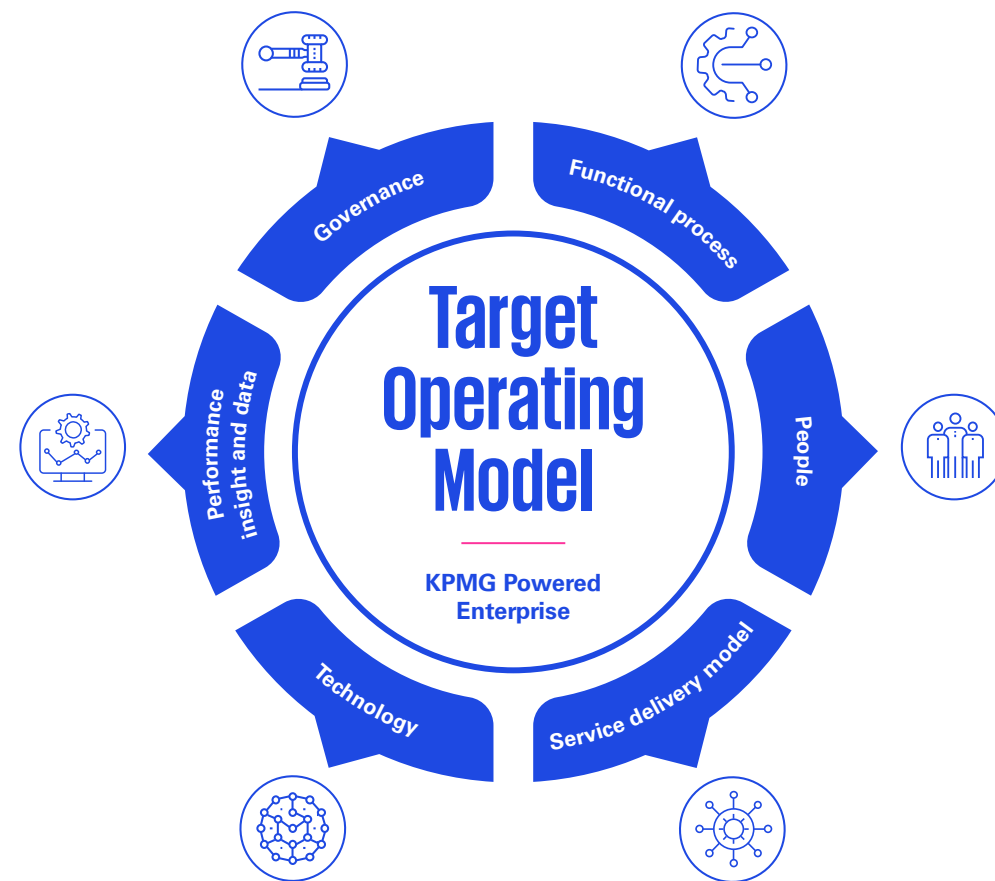
Risks, controls, and security segregation requirements related to processes

Defines where and by whom processes should be performed

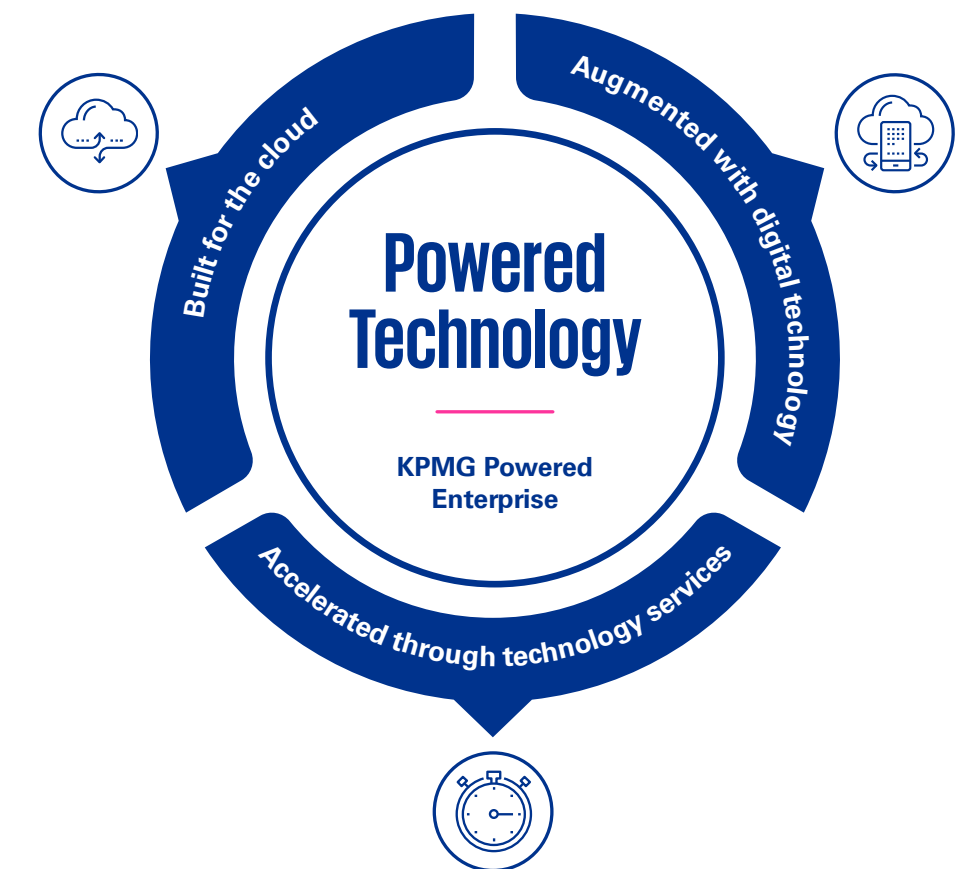

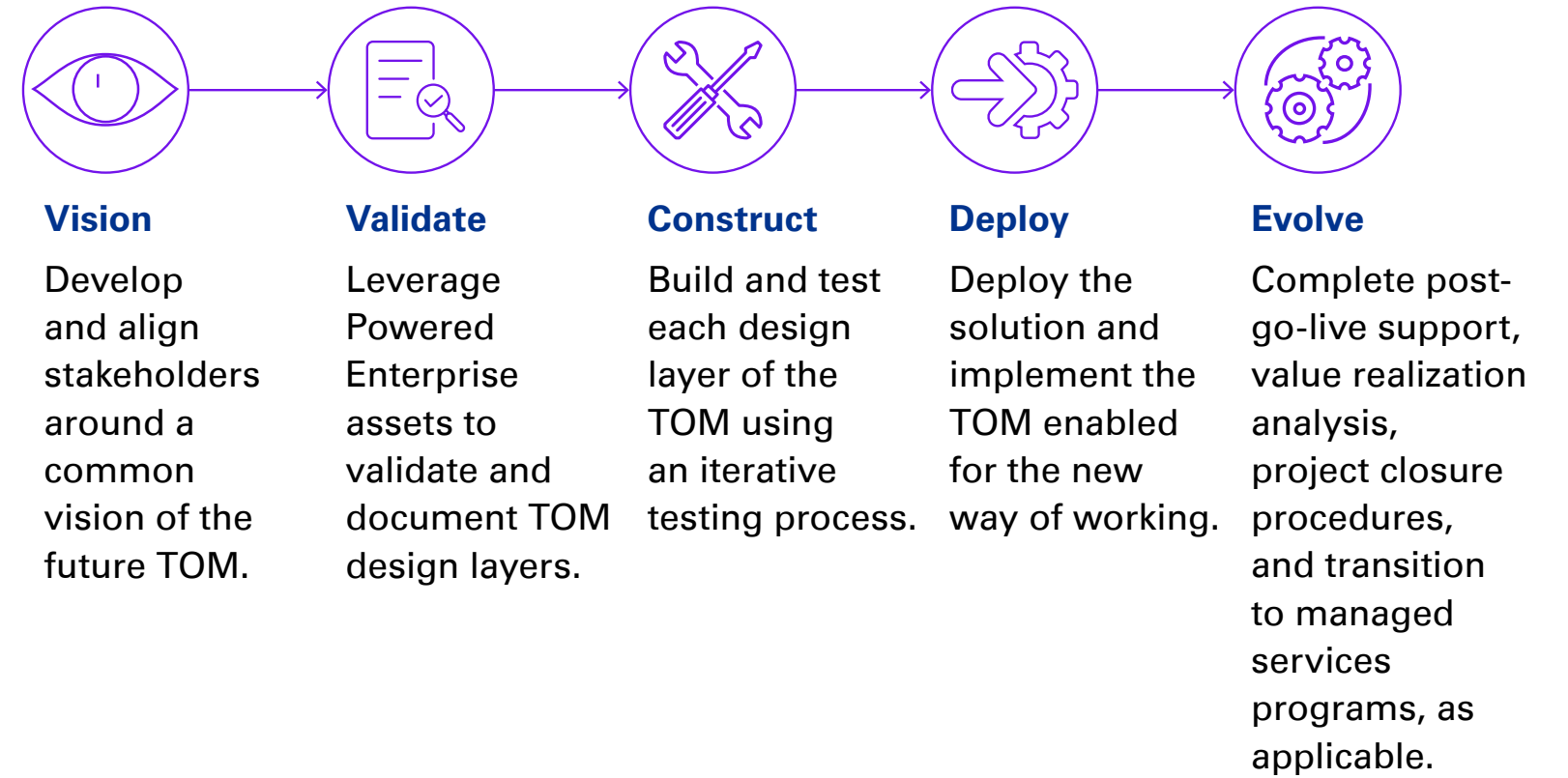
